Agenda Items:

1. Review of 06/22/11 meeting minutes

A motion to accept the minutes was made by Mr. Brobst and seconded by Ms. Rodden. The minutes were approved unanimously.

2. Recycling Revenue Share for Owner Communities

Mr. Roche reviewed the discussion from the 6/22/11 meeting in which the Committee discussed the proposal to begin paying a per ton revenue share to owner communities for their recyclable materials. Per the Committee's request from the last meeting, Ms. Labbe provided a handout that detailed information on all **ecomaine** municipal recycling programs. Mr. Moon further recapped the prior meeting's discussion by recounting that this item had been tabled to allow everyone an opportunity to think about the issue and consider the suggestion to take the next year to work on developing an alternative proposal. After some additional discussion, Mr. Brobst made the following motion:

Motion:

In recognition of current comments and concerns and although the Committee endorses the concept of revenue sharing, the Recycling Committee is recommending and proposing to spend the next year studying the concept and developing a full understanding of the concerns of Board Members with the possibility to make a proposal or recommendation next year (FY 14).

The motion was seconded by Mr. Van Gaasbeek and the motion was accepted by unanimous vote.

3. Catalog Choice Update

Ms. Labbe reviewed handouts that provided illustrations of the proposed website home page for **ecomaine's** Catalog Choice registration page. The service's official start date will be September 12, 2011, and the official rollout will be in conjunction with the annual open house on September 24th. A terminal will be set up at the open house, which will allow attendees to register for the Catalog Choice service at the event.

4. 2012 Media Campaign Update

Mr. Roche explained that the video ad being produced by WCSH was still in process and was not yet ready. The ad, which will start in September, will run throughout the next year on Channel 6-WCSH. WCSH has the largest television viewership of any channel in Maine.

5. Open House Update

Ms. Labbe reviewed a handout announcing this year's annual recycling open house scheduled for September 24th from 8:30 to 11:30am. The open house will be held at the

ecomaine recycling facility and will feature a live broadcast from 93.1 “The Coast” radio station, and booths from local businesses such as Ruth’s Reusable Resources, Goodwill and Women Out Working. Tours will be available of both the recycling facility and the waste to energy facility as well as other family friendly activities. Ms. Labbe asked that members spread the word about the event.

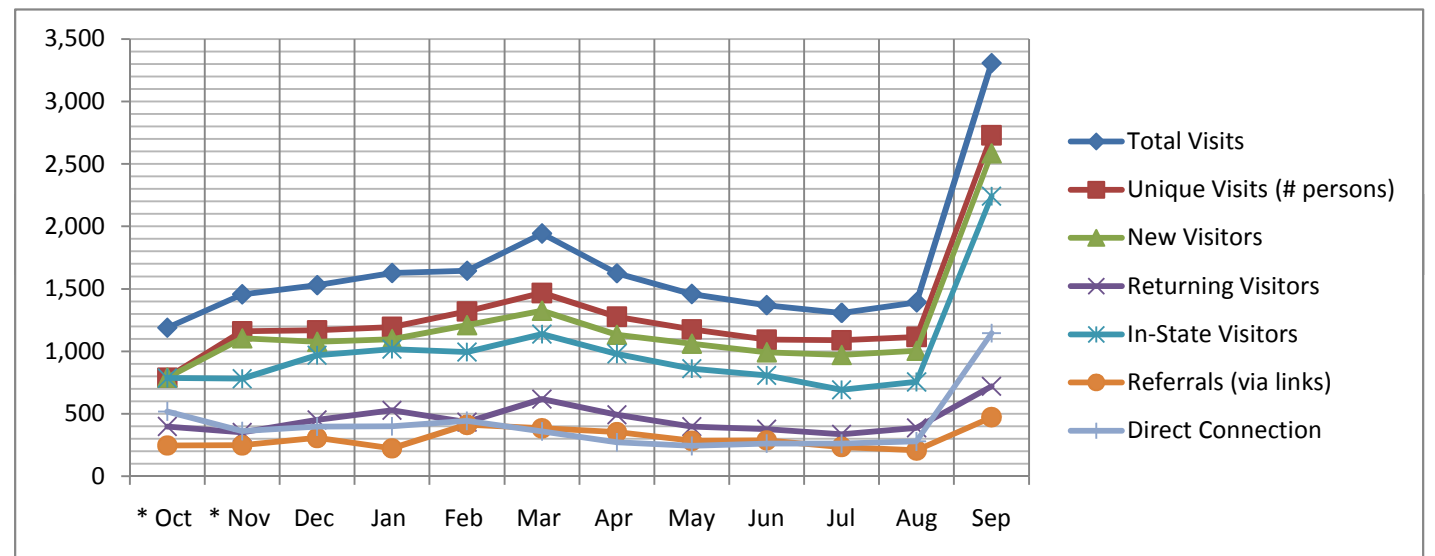

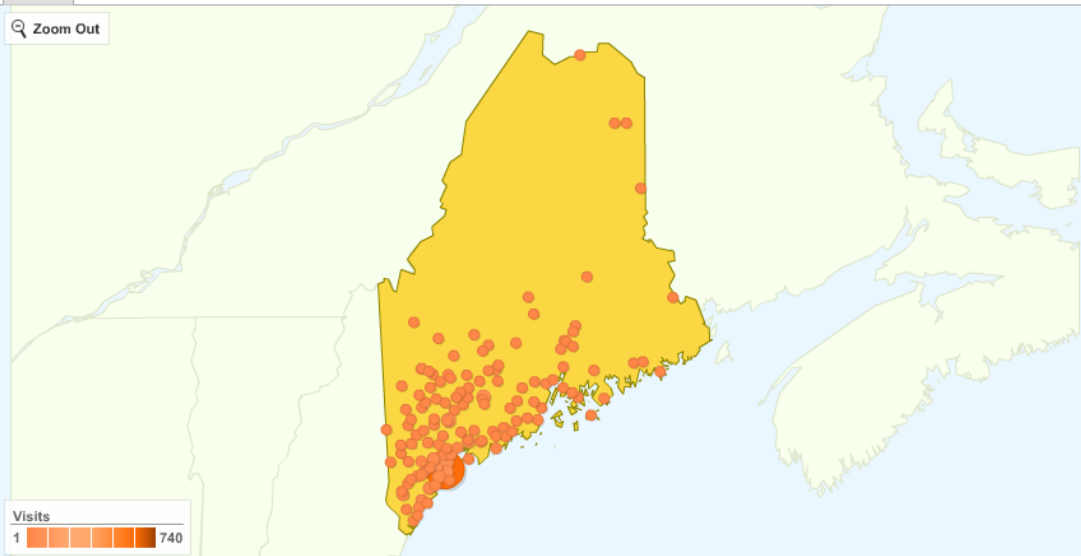

New Public Service has Already Prevented Waste and Emissions

In just one month (September 13 – October 13, 2011) 132 households and businesses have taken advantage of a free national registry to stop more than 3,000 pounds of unwanted advertising mail per year. ecomaine, a municipally owned waste and recycling facility serving 43 Maine communities, reports that it's new partnership with Catalog Choice, is off to a great start.

Troy Moon, board member and chairman of ecomaine's recycling committee, said, "After just one month of on-line registrations, 132 households, combined, have prevented the production of 9,523 pounds of carbon dioxide a year and saved 22,906 gallons of water a year."

Of these figures, Bridgton is responsible for preventing 30 pounds of carbon dioxide and 71 gallons of water, and Harrison for 15 pounds of dioxide and 36 gallons of water. [Nothing has, yet, been recorded for Casco or Naples.]

Ron Dyer, director of the Bureau of Remediation & Waste Management at the Maine Department of Environmental Protection, said, "On behalf of the department, I applaud ecomaine for their leadership in partnering with the Catalog Choice for Communities program and engaging citizens in being stewards of sustainability and offering them the tools that make meaningful action toward reducing their environmental impact accessible. If just 10 percent of the households in ecomaine's 43 communities sign-up for this service, each year we would see more than 12 million pieces of junk mail stopped at the source."

Communities that own or use ecomaine services can register and select which advertising mail they no longer want to receive by visiting the www.ecomaine.org home page. The free service is available to businesses as well as households.

Moon explained, "Catalog Choice is secure and does not reveal any personal information whatsoever, but does track quantities by zip code to help us determine success of the effort." Through that record ecomaine knows the five Maine zip codes which, in the first month of the campaign, have prevented the most pounds of waste and emission per year:

1. 04103 (Portland)
2. 04105 (Falmouth)
3. 04102 (Portland)
4. 04074 (Scarborough)
5. 04101 (Portland)
